♦ Sounds familiar . . . Beginning April 6, 2001, the Australia Maritime Safety Authority will require ships of 400 gross tons or more that are carrying oil as a cargo or bunker to have a "relevant insurance certificate" on board when visiting an Australian port. The requirement will not apply to tankers that are covered under the International Convention on Civil Liability for Oil Spill Damage 1992, and for most vessels, a standard P&I Club Certificate of Entry will suffice. Beginning July 1, 2001, international ships calling on Australian ports will be required to exchange ballast water at sea or use a new Australian ballast water "Decision Support

System" that provides the Australian Quarantine and Inspection Service with details of the ballast water uptake and its intended discharge. Ballast water deemed "low risk" under the system would not require treatment. (Source: *Maritime Items*)

- ◆ On the move . . . Seacor Smit Inc., parent company of SCAA-member National Response Corporation ("NRC"), recently bought Gilbert Cheramie Boats in an all cash deal valued at \$61 million. The company will acquire one newly delivered offshore supply vessel, fourteen minisupply vessels, and eight utility vessels through the purchase. Seacor Smit Inc. also acquired SCF Corporation, a company that owns and operates inland river barges and is primarly owned and controlled by certain Seacor directors. SCF owns 43 barges and is the 50% owner of a partnership that owns eleven additional barges the barges and partnership interest are valued at about \$7.5 million. SCF also manages a barge fleet of 262 units and owns 254,380 shares of Seacor's common stock. (Source: Lloyd's List and Maritime Reporter)
- ◆ The National Pollution Funds Center (NPFC) is offering two of its popular two-day Funds Use Seminars in 2001. The first will take place May 1-2, 2001 at the Omni Corpus Christi Hotel, Marina Tower, 707 North Shoreline Boulevard in Corpus Christi, Texas. The second will take place June 26-27, 2001 at the Doubletree Hotel-Jantzen Beach, located at 909 North Hayden Island Drive in Portland Oregon. The program has been expanded to four concurrent sessions that will cover a broad array of topics, including financial management, Coast Guard and EPA cost documentation, claims, COFRs, state removal cost claims, contracting, and NEW topics including natural resource damage claims, an integrated NRD case study, and legal issues for abandoned oil wells. - ◆ At the web site <u>www.equasis.org</u>, you can have free access to a database that logs essential information on over 66,000 ships. Information listed for the vessels include the name of the P&I Club, classification society, list of port state controls, registered owner and/or ship manager, previous ship managers, IMO number, call sign, and more. To gain access to the information and searchable database, users simply need register to obtain a user name and password. The web site is funded by the European Commission ("EC") and the French government, and is operated under a memorandum of understanding signed by the EC, the maritime administrations of the UK, France, Japan, Spain, Singapore, and the U.S. Coast Guard.
